Call to Order

Meeting was called to order at 6:00 PM

Swearing In of New Members

Roll Call

Members present were: Knust, Miller, Peterson, Comparato, Battrell, Mueller, Phillips, Erbes, Snyder, Rendleman, Ikner, Lister, Calandro and Bost. No members were absent.

Election of Chairman

Byrd asked for nominations for County Board Chair. Lister was nominated by Battrell, Calandro was nominated by Snyder, Mueller was nominated by Ikner and Erbes was nominated by Phillips. Byrd closed nominations and then began a roll call vote:

- First Vote: LISTER (4 votes) - Miller, Rendleman, Battrell, Lister. CALANDRO (4 votes) - Calandro, Snyder, Peterson, Comparato. MUELLER (2 votes) - Mueller, Ikner. ERBES (4 votes) - Knust, Phillips, Bost, Erbes.
- Second Vote: LISTER (4 votes) - Miller, Rendleman, Battrell, Lister. CALANDRO (4 votes) - Calandro, Snyder, Peterson, Comparato. MUELLER (2 votes) - Mueller, Ikner. ERBES (4 votes) - Knust, Phillips, Bost, Erbes.

- Fourth vote: LISTER (4 votes) - Miller, Rendleman, Battrell, Lister. CALANDRO (5 votes) - Calandro, Snyder, Peterson, Ikner, Comparato. MUELLER (1 vote) - Mueller. ERBES (4 votes) Knust, Phillips, Bost, Erbes.
- Fifth vote: LISTER (5 votes) - Knust, Miller, Rendleman, Battrell, Lister. CALANDRO (8 votes) - Phillips, Bost, Erbes, Calandro, Snyder, Peterson, Ikner, Comparato. MUELLER (1 vote) - Mueller. ERBES (0 votes)

Calandro elected to position of Chairman by majority vote.

Election of Vice-Chairman

Calandro asked for nominations for County Board Vice-Chair. Erbes was nominated by Phillips and Mueller was nominated by Ikner. Calandro closed nominations and then began a roll call vote:

- First vote: ERBES (7 votes) - Knust, Phillips, Bost, Erbes, Calandro, Snyder, Peterson. MUELLER (7 votes) - Mueller, Miller, Rendleman, Ikner, Comparato, Battrell, Lister.
- Second vote: ERBES (8 votes) - Knust, Phillips, Bost, Erbes, Calandro, Snyder, Peterson, Rendleman. MUELLER (6 votes) - Mueller, Miller, Ikner, Comparato, Battrell, Lister.

Erbes elected to position of Vice-Chair by majority vote.
